# Focus Shifts to Ag Policy and Funding Following Reconciliation Passage

After providing \$67 billion in assistance for farmers and expanding work requirements for the Supplemental Nutrition Assistance Program (SNAP) last week through passage of the One Big Beautiful Bill, Congress turns its focus to negotiations for a potential "skinny" farm bill. House Ag Chair G.T. Thompson (R-PA) said he expects the "farm bill 2.0" to cost less than \$8 billion. Democrats have said that they won't come to the table for farm bill talks after Republicans significantly cut climate and nutrition spending — which are traditionally Democratic priorities in the farm bill coalition. The reality is that most members with ag interests won't be able to vote against a farm bill that reauthorizes essential farm and rural development programs in the run-up to an election year — especially those in competitive districts.

# **Ag-Rural Development-FDA Funding Moves in Both Chambers**

This Thursday, the Senate Appropriations Committee is marking up its FY26 Agriculture-Rural Development-FDA funding bill. The Senate's bills is expected to be significantly closer to FY25 spending levels than the <a href="House Appropriations Committee's bill">House Appropriations Committee's bill</a>, which was voted out of committee last month and would cut more than \$1 billion (4 percent) of current federal funding for USDA and FDA and codify Trump Administration priorities, like getting rid of diversity, equity and inclusion-related initiatives at USDA and reducing the department's workforce and funding to prepandemic levels.

# White House Threatens to Raise Tariffs on Growing Slate of Trade Partners

President Trump is threatening to significantly raise tariffs on Japan, South Korea, Myanmar, South Africa, Laos, Malaysia, and Kazakhstan anywhere from 25 to 40% as the White House continues to negotiate trade deals with the countries ahead of a new August 1 deadline. A second round of tariff increases for Thailand, Cambodia, Serbia, Bangladesh, Indonesia, Tunisia, and Bosnia and Herzegovina was also announced later the same day. North Korea and Japan have already been involved in comprehensive trade negotiations with the U.S. for months, but talks have stalled over their refusal to boost defense spending and agricultural imports.

# **FY2025 Disaster Recovery Grant Program**

# **Mutual Self-Help Housing Technical Assistance Grants**

# **U.S. Department of Agriculture**

USDA Rural Development provides grants to organizations to help them carry out local self-help housing construction projects. Recipients supervise groups of very-low- and low-income individuals and families as they construct their own homes in rural
